



PRODUCT WARRANTY

With the exception of items listed below, this product has a limited warranty against defects in materials or workmanship for a period of one year from the date of installation.

Exceptions:

1. Faucet stem cartridges have a limited warranty for a period of 100 years from date of manufacture.
2. Product finishes have a limited warranty for a period of 100 years from the date of installation excluding oil rubbed bronze and matte black finishes. Failure to follow the cleaning instructions listed below voids all finish warranty. Damage due to accidents or installation is not warranted.

This warranty covers replacement of cartridges and finish only and does not include labor charges and/or damage incurred in installation. Finish warranty is not covered if finish is exposed to extreme use of cleaners containing abrasives, alcohol, extreme cleaning, or chemical use, or damage due to abuse or neglect. **Please see cleaning instructions provided with each faucet. This warranty excludes all industrial, commercial, and business usage of faucets and only pertains to residential use. Faucets used for other than residential use are covered by a 1-year limited warranty from the date of purchase.

CLEANING INSTRUCTIONS

USE ONLY A CLEAN, SOFT CLOTH, WATER, AND MILD HAND SOAP TO CLEAN UNIT.
